**“Oil-Canning” Acknowledgement and Disclaimer**

The undersigned hereby acknowledges that perceived waviness in flat metal commonly known as “oil-canning” is an inherent part of light gauge cold formed metal panels such as the purchased UCC product. Union Corrugating Company does not consider “oil-canning” to be a warranted defect, nor is “oil-canning” a valid basis for rejection of an installed panel system. Panels supplied by UCC without striations may be more susceptible to oil-canning due to the wide, flat surfaces. Stiffening ribs and striations located in the flat pan of standing seam roof panels are means of reducing this condition. However, all metal panels MAY experience the visual perception of oil-canning.

By signing below I acknowledge that waves and other surface variations (“oil-canning”) are not accepted reasons for rejection of standing seam roof panels provided by Union Corrugating Company, and such rejections shall not be honored. I understand that panels made with no striations are more likely to exhibit these characteristics. I have received and reviewed the MCA bulletin on oil canning.

I further acknowledge that I am the Owner of the real property where the UCC materials are to be installed, or an agent for the Owner. In the event the undersigned is not the Owner or an agent therefor, the undersigned agrees to indemnify and hold UCC harmless against any claims or damages as a result of a claim for rejection of the UCC product by the Owner.
